

BEST PRACTICE 1-

"INDERPRASTHA DENTAL HEALTH AWARENESS MISSION" IN RAISPUR VILLAGE



OBJECTIVES:

- To generate awareness of oral health among the villagers.
- To motivate the people to seek dental treatment.
- To provide dental treatment to the villagers in their vicinity.
- To develop and plan strategies to meet the needs of patients in the village.
- To provide transportation services for the patients to reach the Hospital for accessing advance treatment.

CONTEXT:

Inderprastha Dental programme "INDERPRASTHA DENTAL HEALTH AWARENESS MISSION" in association with gram panchayat Raispur, with an aim to provide oral health awareness and treatment to people in rural areas.

IPDC has established a clinic in Village Raispur, with a population of 15000, empowered population of Raispur access dental treatment; provide opportunity for college student to work in rural set up.



IPDC provides transportation to villagers every Wednesday, patients requiring advance dental treatment can access facilities.

PRACTICE:

Door-to-door health awareness campaign was conducted by students in the village from March 2022. The people were motivated to practice good oral hygiene. IPDC then set up a clinic for dental health in the village in April 2022 for patients to seek the primary treatment in their own neighbourhood.

The Satellite Clinic in association with Gram Panchayat is located in the heart of the village providing all the basic treatment to villagers free of cost. We at IPDC also believe dental education will be better since students get an opportunity to work in rural set up. At satellite clinic, all age group patients are catered from paediatric to geriatric. Patients can access treatment like scaling, restorations, splinting and extractions.

Advanced Treatment: Patients requiring advanced treatment are provided with transportation every Wednesday, so that they can visit IPDC and seek the treatment.

EVIDENCE OF SUCCESS:

- There has been an increase in footfall of patients in Clinic at Raispur ever-since the clinic started operating.
- People of Raispur practice oral hygiene regimens.
- Patients are now utilizing the transport facility provided by IPDC and an increase in patients visiting IPDC for advance dental treatment.
- Students display ample confidence to peruse mass clinical practice and patient management.

CHALLENGES ENCOUNTERED AND RESOURCES REQUIRED

• The biggest challenge in the execution of this practice was the fact that Gram Panchayats of many villages were not supportive and willing to launch the program by providing space for the clinic set-up.




- Managing mass population due to local language barrier.

Advantages:


- Students learn how to treat patients.

Treatment summary of patients being treated at Raispur - Year 2022




Total number of cases being treated









MEMORANDUM OF UNDERSTANDING

On this day 1st April 2022, at Ghaziabad.

This MOU is made between INDERPRASTHA DENTAL COLLEGE & HOSPITAL, 46/1, SITE IV, Industrial area, Sahibabad, Ghaziabad, U.P - 201010, represented through its Secretary Mr. Nimish Agarwal, hereinafter referred to as the "COLLEGE"

AND

between Mr. Manoj Chaudhary, Councilor of RaispurVillage, District Ghaziabad, Uttar Pradesh, hereinafter referred to as the COUNCILOR.

The COLLEGE will adopt the village for dental healthcare andestablish a Charitable Dental Clinicin the premises of Samudaik Kendra, RaispurVillage, Shaheed Bhagat Singh Chowk, Ghaziabad, Uttar Pradesh for the charitable dental treatment of the residents of village.

The COUNCILORshall provide free of charge the following infrastructure for setting up of the Dental Clinic.

The COUNCILOR shall provide free of charge water and drainage services.

The COLLEGE shall install an electric connection at its own costs, and shall provide all equipment for setting up of dental clinic including Dental Chair, Air Compressor, Autoclave, Scaler, X-Ray etc.

The COLLEGE shall also provide manpower for running of the clinic.

The COLLEGE shall also provide consumables for the dental clinic such as tooth filling, X-Ray film etc.

The COLLEGE shall run charitable Dental Clinic within the premises of the Samudaik Kendra, once a weeki.e, Tuesday from 9:00 a.m to 2:00 p.m during which the COLLEGE shall provide the required manpower to treat the patients of the village.

Also, it is to be noted that not all the dental treatments can be done with the limited manpower and equipment available at the village premises. Hence the COLLEGE may advice the patient to visit the COLLEGE for full dental treatment and it is optional for the patient to seek dental treatment at the premises of the COLLEGE or elsewhere. If however the patient chooses to get the dental treatment at the premises of the COLLEGE then such treatment shall be on chargeable basis at the prevailing rates of the COLLEGE at that time.

The COUNCILOR shall provide adequate security to ensure no incident of theft/robbery take place.

The COUNCILOR shall provide complete cooperation to the manpower of the COLLEGE working in their premises.

This MOU is valid for a period of 2 years from the date of signing, and can be renewed further subject to consent of both of COLLEGE and the COUNCILOR, in writing only. If due to any reasons/dispute this MOU is discontinued, then:-

- The COUNCILOR shall be liable to Return all equipment of the COLLEGE.
- Neither the COUNCILORnor the COLLEGE shall be liable for reimbursement of any expenditure or investment made towards this MOU.
- All disputes shall be subject to jurisdiction of Ghaziabad.
